AN ACT to amend the Mount St. John's Medical Centre Act, 2009 and for incidental and connected purposes.

ENACTED by the Parliament of Antigua and Barbuda as follows—

1. Short title

This Act may be cited as the Mount St. John's Medical Centre (Amendment) Act, 2015.

2. Interpretation

"Principal Act" means the Mount St. John's Medical Centre Act, 2009.

3. Amendment of section 2-Interpretation

Section 2 of the principal Act is amended as follows:

- (a) by deleting the definition of "Chief Executive Officer" and "Director of Finance"
- (b) by inserting the following definitions in their appropriate alphabetical order.

5. Amendment of section 12-Appointment of Medical Director

Section 12 of the principal Act is amended by deleting subsection (2) and substituting therefor the following—

"(2) The Medical Director shall be responsible to the Board for the supervision of the Medical and Dental care given to all patients of the hospital in accordance with the policies established by the Board".

6. Amendment of section 15-Clinical Department and Services

Section 15 (2) of the principal Act is amended by the deleting "Chief Executive Officer" and substituting therefor "Director of Administration".

"Director of Administration" means the person appointed to be Director of Administration under section 11.

"Financial Controller" means the person appointed to be Financial Controller under section 11.

4. Amendment of section 11

Section 11 of the principal Act is amended as follows:

(a) by deleting the head note of section 11 and substituting therefor the following:

"Appointment of Director of Administration, Financial Controller and Senior Management Personnel.

- (b) by deleting subsection (1) and substitute the following:—
- "(1) The Board may appoint at such remuneration, and on such terms and conditions as it considers appropriate a Director of Administration"
 - (c) by deleting subsection (2) (b) and substituting therefor the following—
- "(2) A Financial Controller who shall be a full time officer of the Board and be responsible to the Board through the Director of Administration for the efficient management of the financial administration of the hospital."
 - (d) in subsection (4), delete "instead of a Chief Executive Officer".
 - (e) in subsection (5), delete 'Director of Finance' and substitute the "Financial Controller".
 - (f) insert after subsection (5) the following new subsection—
- "(6) The Director of Administration shall, subject to the provisions of the Act be responsible for the general administration of the hospital".
- "(7) Without prejudice to the provisions of subsection (1) the general administration of the hospital include the administration and supervision of the following departments
 - i) Public Relations
 - (ii) Information Technology
 - (iii) Landscaping, Safety and Security
 - (iv) Orderlies
